#### FIRST REPORT BY MORTGAGEE IN POSSESSION OF LAND

IN THE MATTER of Part 3, subpart 6 of the Property Law Act 2007 (the "Act") and Memorandum of Mortgage 6263473.2 over estates in fee simple in the land described and comprised in Certificates of Title 206604. 206605, 206606 and 206607. Canterbury Registry (the Mortgage)

On 21 June 2010, SOUTH CANTERBURY FINANCE LIMITED (the "Mortgagee") pursuant to section 156 of the Act, and its rights secured by Mortgage Number 6263473.2 (the "Mortgage") and its rights pursuant to a notice issued under section 119 of the Act entered into possession of part of the mortgaged property from Hanmer Springs Thermal Resort Apartments Limited (the "Mortgagor").

In accordance with section 162 of the Act the Mortgagee provides the following report:

### **PARTICULARS OF LAND**

The Mortgagee is now in possession of part of the mortgaged property being the properties at 5, 7, 9 and 9A Mt Charon Place, Hanmer Springs described in Certificates of Title 206605, 206606, 206607 and 206604 (Canterbury) more particularly described as Lot 2 Deposited Plan 350521, Lot 3 Deposited Plan 350521, Lot 4 Deposited Plan 350521 and Lot 1 Deposited Plan 350521 (the "Land").

#### PARTICULARS OF DEBTS AND LIABILITIES 2

The Mortgagor is indebted to the Mortgagee in the sum of \$1,305,206.10 plus accruing interest. This debt is secured to the Mortgagee by, inter alia, the Mortgage.

This caveat was registered against the land on 21 June 2010.

- The Mortgagor defaulted on its obligations to the Mortgagee in that the Mortgagor failed to comply with a notice issued under section 119 of the Property Law Act 2007.
