1. INTRODUCTION

We, Brian Mayo-Smith and Andrew James Bethell, of BDO Auckland and Stephen John Tubbs, of BDO Christchurch, all Chartered Accountants (“the Liquidators”), were appointed joint and several liquidators of the Companies on 28 February 2013 by special resolution of the shareholders in accordance with Section 241(2)(a) of the Companies Act 1993 (“the Act”) with approval of the High Court. A copy of the originating application and sealed orders are attached as **Appendix 1**. A copy of the public notice of appointment is attached as **Appendix 2**.

Liquidators of insolvent companies have the same statutory powers and duties regardless of whether they are appointed by the Court or special resolution of the shareholders. Neither BDO nor the Liquidators have any prior professional relationship with the shareholders, other than the appointment noted below.

A related company, King Facade Limited (In Liquidation) (“KFL”), was earlier placed into liquidation on 12 February 2013. The same liquidators were appointed. A report has previously been prepared in relation to KFL which is available on the Companies Office and BDO websites.



MPCL and MLL, the two principal trading entities, had already been placed into receivership on 6 February 2013 and 200VL followed on 13 February 2013. Colin McCloy and David Bridgman (“the Receivers”) of PricewaterhouseCoopers (“PwC”) were appointed receivers at the request of the remaining director. The Receivers remain in control of the business and assets of these Companies. We would expect that they will retire and hand residual assets to the Liquidators if and when their appointor is repaid in full and they have fulfilled their statutory and contractual obligations.

The Companies are ultimately part of complex group of entities (“the Group”) that relied on entities operating beyond New Zealand borders. This increases the complexity of the liquidations.

MPCL is the main trading company for the Group. It was a construction company and also held fixed assets such as a property in Mt Wellington, plant and equipment and held titles for residential properties being constructed in Christchurch by MLL.

We understand that MLL was set up as a residential construction company. We note however that supplier invoices were processed and paid through MPCL.

200VL is also in receivership and owns substantial property. However, this property is subject to a first ranking mortgage to a secured creditor, which is cross co-lateralised.

MGL holds shares in MPCL and MLL. These were previously held by Richina Global Real Estate Limited (a company not in receivership or liquidation) but transferred in December 2012. We intend to review the effect and validity of this transaction in more detail.

We have been advised that the remaining entities are non-trading but a number were set up in order to effect an operational restructure of the Group’s activities, which was not completed.

In accordance with section 255 of the Act, we report on the Companies affairs together with our proposals for conducting the liquidations.

2. RESTRICTIONS

This report is not intended for general circulation, nor is it to be reproduced or used for any purpose other than that outlined above without our written permission in each specific

instance. We do not assume any responsibility or liability for any losses occasioned to any party as a result of the circulation, publication, reproduction or use of this report contrary to the provisions of this paragraph.

We reserve the right (but will be under no obligation) to review this report and if we consider it necessary to revise the report in the light of any information existing at the date of this report which becomes known to us after that date.

3. BACKGROUND AND REASONS FOR LIQUIDATIONS

MPCL, in particular, relied upon support from entities outside New Zealand. It appears that the recent withdrawal of that support was the catalyst for the remaining director to request the Bank to appoint receivers. Receivers were consequently appointed on 6 February 2013 and subsequently the Companies were placed in liquidation.

Other key factors in the Group's demise appear to include:

- The uncertainty over the recoverability of large related party debts;
- Substantial losses on a number of large construction contracts;
- Substantial existing or pending legal claims;
- Substantial agreed remedial works in progress;
- Large losses incurred with the setup and operation of KFL;
- The working capital requirements of setting up and operating MLL;
- Declining work volumes due to the cyclical downturn in commercial construction, causing consequential adverse impacts on working capital; and
- An adverse settlement on a major infrastructure contract.

As previously mentioned, we were appointed liquidators of KFL on 12 February 2013. Upon our appointment we were made aware of a large level of related party balances and that accounting and information systems of the Group (which includes the Companies) were intermingled.

For these reasons, the appointment of the same liquidator across the Group should provide the ability for the Liquidators to deal with the complex related party positions efficiently. In addition, liquidators under the Act are provided with investigatory powers and statutory provisions which allow them to, in certain circumstances, unwind transactions and/or seek payments from third parties (for example, persons who have been preferred or benefited

from transactions at an undervalue) for the benefit of all unsecured creditors. These powers are different powers to those available to receivers.

5. STATEMENTS OF AFFAIRS

Attached at **Appendix 3** are the Statements of Affairs of certain of the Companies. These statements have been prepared solely based upon financial records provided by the Companies predominantly as at 31 December 2012 and 31 January 2013 (MGL). Statements of Affairs have not been provided for those companies which we have been advised do not trade and have no known assets or liabilities. Our investigations will seek to confirm this.

Notes accompany the Statements of Affairs.

The Statements of Affairs do not include any allowance for the cost of realisation, receivers' costs, legal fees, on-going overheads, liquidators' costs or contingent creditors. In addition, it is too early to assess likely realisable values or the level distributions (if any) to preferential and unsecured creditors.

In preparing the statements we have relied on information provided by staff and directors of the Companies. We have not carried out an audit of the information which has been provided, nor have we subjected the information provided to detailed verification procedures. Whilst the information provided to us from the Companies' records provides an insight into the affairs and financial position of the Companies' we have concerns about the accuracy of this information and believe that many balances warrant further investigation.



We cannot be held responsible for inaccuracies in the report arising from deficiencies in the information or explanations given to us. We note that the information provided to us shows the balances as at 31 December 2012 and 31 January 2013 (MGL) and therefore will change when information regarding January creditors and contingent creditors becomes available and is processed.

We have also met separately with the director of the trading and some other companies, and certain former directors all of whom have been very accessible and willing to provide assistance and information.

Likewise we have met with the Receivers who have assisted in supplying information for this report.

6. CREDITORS MEETING

The Liquidators advise that a meeting of creditors will be held for MPCL, MLL, 200VL and MGL at the Newmarket Room of the Ellerslie Event Centre, 80 Ascot Avenue, Remuera, Auckland on Wednesday 3 April 2013 at 2.30pm. A copy of the public notice of the creditors' meeting is included within **Appendix 4** of this report. The Liquidators will be inviting and encouraging the directors of the Companies to attend the meeting but it should be noted that we are unable to compel them to do so.

We will invite the Receivers to attend the creditors' meeting.

In accordance with section 245 of the Act, for the reasons given in the formal notice attached at **Appendix 5**, we have dispensed with the meeting of creditors for BFGHL, BFGI, MRL, MCL, ML, MCSIL, MPCNZL and RGREL.

7. CREDITOR CLAIMS

All creditors of the Companies are to submit a prescribed claim form to the Liquidators. This form is included in the creditors' information pack sent to all known creditors. If you have completed a claim form for the Receivers, you are also required to complete a claim form for the Liquidators. We will seek to cross reference this with the Receivers' records but we will not be able to admit a claim not received in the prescribed form.

To the extent you are a creditor of one or more of the Companies and you have not received the creditors' information pack (containing an Unsecured Creditors Claim Form), please contact the Liquidators at the address below as soon as possible.

8. PROPOSALS FOR CONDUCTING THE LIQUIDATION

The Liquidators support the appointment of a Liquidation Committee at the creditors' meeting on 3 April 2013 to assist the Liquidators pursuant to section 315 of the Act. The constitution and role of a committee can be summarised as follows:

- a) It must consist of not less than three persons who are creditors or shareholders (including persons holding general powers of attorney from, or who are authorised directors or representatives of companies which are, creditors or shareholders).
- b) A committee has the power to:
 - Call for reports from the Liquidators on the progress of the liquidation;
 - Call a meeting of creditors or shareholders;
 - Apply to the Court under section 284 and section 286 of the Act; and
 - Assist the Liquidators as appropriate in the conduct of the liquidation.

The Liquidators will assess further investigations and actions required subsequent to the further review of information relating to the Companies. Further actions will be subject to availability of funding and an assessment of the benefits of pursuing recoveries.

Areas in which the Liquidators initial analysis has indicated may warrant further investigation include:

- Reasons for the demise;

- Related party positions with entities in New Zealand and overseas including amounts due from companies not in receivership or liquidation;
- Voidable transactions;
- Any Group restructurings carried out;
- Reviewing the actions of management, directors and officers of the Companies;
- Any undertakings provided by related parties; and
- Amounts in suspense accounts not yet allocated.

The Liquidators will comply with their statutory obligations and will ultimately seek to have the Companies removed from the register.

9. ESTIMATED DATE OF COMPLETION

It is not practical to estimate the date of the completion of the liquidations at this stage. Our subsequent reports to creditors and shareholders will, when appropriate, advise of an estimated completion date.

1. The applicants, **ANDREW JAMES BETHELL, BRIAN MAYO-SMITH AND STEPHEN JOHN TUBBS** will on the _____ day of _____ 2013 at _____ am/pm apply to the Court for orders that:

- (a) leave be granted to commence this proceeding by way of originating application;
- (b) leave be granted to proceed without notice of the originating application;
- (c) the applicants be permitted to accept the appointment as joint and several liquidators of the respondents by special resolution of shareholders pursuant to s 241(2)(a) of the Companies Act 1993 (**Act**);
- (d) subject to the orders sought in subparagraphs 1(a), (b) and (c) above being granted, and the applicants being appointed as liquidators by special resolution of the shareholders of the respondents, a copy of this originating application together with the sealed orders be served on all known creditors of the respondents at the same time and in the same manner as the liquidators' first report under s 255 of the Act;
- (e) the creditors of the respondents be granted leave to apply to the Court within 10 working days of service to set aside the applicants' appointment as liquidators of the corresponding respondent; and
- (f) costs be reserved.

2. The grounds on which the above orders are sought are as follows:

Order 1(a): Leave to commence proceeding by way of originating application

- (a) Seeking the orders in paragraph 1 above under the procedure provided by Part 5 of the High Court Rules would cause undue delay in the appointment of liquidators to the respondents.
- (b) Commencing this proceeding by way of an originating application is consistent with the general objective of the High Court Rules to secure the just, speedy, and inexpensive determination of any proceeding.

- (c) It is in the interests of justice that this proceeding be commenced by way of originating application.

Order 1(b): Leave to proceed without notice

- (d) Proceeding on notice will cause undue delay and in any event service on the respondents is not necessary given s 280 of the Act and the nature of the orders sought.
- (e) Not all creditors of the respondents are currently known and personal service on each known creditor will be costly, time-consuming and wasteful of the respondents' resources.
- (f) The creditors' rights are protected by the order sought in paragraph 1(e) above granting them leave to apply to remove the applicants as liquidators of the respondents if they so wish.

Order 1(c): Application for orders allowing appointment

- (g) Section 280(cb) provides:

280 Qualifications of liquidators

(1) *Unless the Court orders otherwise, none of the following persons may be appointed or act as a liquidator of a company:*

...
(cb) *a person who has, or whose firm has, within the 2 years immediately before the commencement of the liquidation, had a continuing business relationship (other than through the provision of banking or financial services) with the company, its majority shareholder, any of its directors, or any of its secured creditors...*


- (h) The second and third named applicants have previously been appointed by Bank of New Zealand (BNZ) as receivers and managers of various companies unrelated to the respondents.
- (i) BNZ is a secured creditor of Mainzeal Property and Construction Limited (In Receivership), Mainzeal Living Limited (In Receivership) and 200 Vic Limited (In Receivership).
- (j) Nevertheless, the applicants have no discernible or material conflict of interest.

- (k) The applicants are experienced, reputable and impartial liquidators who are capable of carrying out the liquidation of the respondents in a professional and effective manner.
- (l) The appointment of the applicants as liquidators of the respondents, will enable them to conduct the liquidations of the respondents together and will ensure the expedient and cost-effective liquidation of the group.

Orders 1(d) and (e)

- (m) The creditors' interests are properly protected in that orders 1(d) and (e) allow for the creditors to challenge the appointment of the applicants.

AFTER READING the originating application without notice for orders permitting the appointment of the applicants as liquidators of the respondents, the affidavit of Brian Mayo-Smith in support, and the memorandum of Z G Kennedy on behalf of the applicants, **THIS COURT ORDERS THAT:**

- (a) leave be granted to commence this proceeding by way of originating application;
- (b) leave be granted to proceed without notice of the originating application;
- (c) the applicants be permitted to accept appointment as joint and several liquidators of the respondents by special resolution of shareholders pursuant to s 241(2)(a) of the Companies Act 1993 (**Act**);
