Introduction

- 1. Strategic Finance Limited was placed into liquidation by order of the High Court at 10.49 am on 26 July 2010 resolving that John Joseph Cregten and Andrew John McKay be appointed joint and several Liquidators of the Company. 10. The Liquidators will take the following steps to identify and realise the assets owned by

Realisation of Assets

11. Receivers have been appointed to realise the assets, primarily the loan book of the

company, for the benefit of secured investors. The liquidation will not impact on the

receivership and the asset realisation process that the Receivers are conducting.

Investigations

12. The Liquidators will review the company's books and records, conduct an initial

investigation into the trading affairs of the company and conduct all other investigations

that the Liquidators are charged to do.

Estimated Date of Completion of Liquidation

13. At this stage it is not practical to estimate the date of completion of the liquidation, as this

1993 including assisting the Liquidators as appropriate in the conduct of the liquidation.
