

HAWKES BAY HOME LOAN AFFORDABILITY REPORT

April 2020

Home loan affordability is a measure of the proportion of take-home pay that is needed to make the mortgage payment for a typical household. If that is less than 40%, then a mortgage is considered 'affordable'. The following are typical assessments for households at three stages of home ownership.



This report estimates how affordable it would be for a couple where both are aged 25-29 and are working full time, to buy a home at the lower quartile price in Hawkes Bay.

It assumes they earn the median rate of pay for people of their age in their region, which would give them a take home pay of \$1,577.76 a week.

It is assumed they would have saved \$71,193 to use as a deposit, by putting aside 20% of their net pay each week for up to four years, earning interest on the savings at the 90 day bank deposit rate.

To buy a home at Hawkes Bay's lower quartile price they would need a mortgage of \$327,807.

They would need to set aside \$335.66 a week to cover the mortgage payments, which would be 21.3% of their take home pay.

Mortgage payments are considered affordable when they take up no more than 40% of take home pay.

On that basis it would be affordable for a young couple earning the median pay rate to buy a lower quartile-priced home in Hawkes Bay.

This report estimates how affordable it would be for a couple with a young family to move up the property ladder and buy their next home at the current median price.

It is assumed that one partner works full time and one works half time and both are paid at the median rate for people of their age in Hawkes Bay, and that they receive the Working for Families allowance.

That would give them total after tax weekly income of \$1,301.55 a week.

It is also assumed they purchased their current home five years ago for \$230,000, which was the lower quartile selling price in Hawkes Bay at the time.

If they sold that home for the current lower quartile price in Hawkes Bay of \$399,000, they would have equity of \$216,307 to use as a deposit on a new home.

If they purchased a home at Hawkes Bay's current median price of \$648,000 they would need a \$431,693 mortgage.

The repayments on this would be would be \$436.14 a week which would be 33.5% of their weekly income.

Mortgage payments are considered affordable when they take up no more than 40% of take home pay.

On that basis it would be affordable for the couple in this example to move up to next rung of the property ladder and buy a home at Hawkes Bay's median price.



OLDER FAMILY 35-39

Older family buyers earn median incomes in their age bracket, and buy a median house in their area. Both partners work full-time.

This report estimates how affordable it would be for a couple who are both aged 35-39 and working full time, to move up the property ladder and buy their next home at the current median price.

It is assumed that both are paid at the median rate for people of their age in Hawkes Bay, and that they no longer receive the Working for Families allowance.

That would give them total after tax weekly income of 1,719.50 a week.

It is also assumed they purchased their current home 10 years ago for \$219,000, which was the lower quartile selling price in Hawkes Bay at the time.

If they sold that home for the current lower quartile price in Hawkes Bay of \$399,000, they would have equity of \$244,262 to use as a deposit on a new home.

If they purchased a home at Hawkes Bay's current median price of \$648,000 they would need a \$403,738 mortgage.

The repayments on this would be would be \$407.89 a week which would be 23.7% of their weekly income.

Mortgage payments are considered affordable when they take up no more than 40% of take home pay.

On that basis it would be affordable for the couple in this example to move up to next rung of the property ladder and buy a home at Hawkes Bay's median price of \$648,000.

HOUSE PRICES

The median house price was \$648,000 in April, up from \$543,000 last month. The median house price was \$465,000 in April 2019 which puts annual growth at 39.4%. Five years ago the median was \$315.000.

Dwelling sales in April were 39, down from March's 232. They are now lower than the 230 sales twelve months ago and lower than the 196 sales five years ago.

The lower-quartile house price was \$399,000 in April, unchanged from \$399,000 last month. Annual growth was 10.8%, from the \$360,000 lower-quartile house price in April last year.

INTEREST RATES AND MORTGAGE PAYMENTS

The average bank interest rate for two year fixed mortgage rate was 3.302% for April, -67 basis points less than the 3.974% twelve months earlier.

Prior to the emergency rate cuts in March by the RBNZ, market mortgage rates were stable but soft. But as many countries shut down with the advancing Covid-19 coronavirus, the prospect of low fixed rates falling further is rising. Our model assumes borrowers switched to a 2

vear fixed rate in June 2014. following the shift reflected in RBNZ data.

Sources / Definitions / Methodology

***a typical buyer:** An individual in the 30-34 year old age group who buys the median house price with 20% deposit. ***a first home buyer :** An individual in the 25-29

Interpreting the Index:

The home loan affordability index measures the proportion a weekly mortgage payment is of weekly take-home pay (for a median priced house). An index measure is generated for each region, and nationally. We calculate, but do not publish, this index using other various mortgage interest rate terms.

Interpreting the Household Income Models:

A mortgage is 'affordable' when the mortgage payment is no greater than 40% of household weekly take-home pay. The value of the mortgage is based on the rules below (see Home Loan).

Weekly Income:

From the July 2007 Report onward, the source on which we base our estimates of weekly income, is now the LEEDS (Linked employer- employee data survey) data from Statistics New Zealand.

The standard home loan affordability report is based on the LEEDS data for the 30-34 age group.

Income tax rates from IRD are used to calculate a take-home pay (which is the LEEDSbased data net of the specific income tax rate).

Home Loan: (Median house price less a 20% deposit) Mortgage repayments are based on the value of the home loan, paid weekly for 25 years, using the bank average interest rate. The home loan is assumed to be a standard table mortgage, where both interest and principal is repaid in a fixed weekly payment made in arrears. The repayment is calculated using the tools at http://www.interest.co.nz/calculators/mortgage-calculator

Mortgage Rates:

Average mortgage interest rates are sourced from www.interest.co.nz. These averages are for banks only as banks have 90%+ of the mortgage market. Affordability calculations are done for mortgages at the floating rate and one year through to the five fixed-rate terms. In this report, the two-year fixed mortgage interest rate is used. Until August 2010 this series used a 2 year fixed rate loan as the basis for interest rates. In September 2010 it was switched to the floating rate, reflecting actual market shifts by borrowers. In June 2014, it was switched back to the 2 year fixed rates, again reflecting market shifts.

House price data:

Median house prices are as reported by the Real Estate Institute of New Zealand. Although the REINZ series is more volatile than the QV equivalent, there is a highly positive correlation between the two series. The REINZ series is more current and offers an earlier indication of market trends.

Saving Rates:

Average savings interest rates are sourced from www.interest. co.nz. These averages are for banks only, and use the 90 day term deposit rate. Saving calculations take into account the individuals marginal tax rates as defined by IRD. Household affordability:

Household affordability is calculated in the same way as individual affordability except instead of individual income, a household income is used. The household income for a standard-buyer household is made from 1 full time male median income, 50% of a female median income (from LEEDS data) both in the 30-34 age range, plus the Working For Families income support they are entitled to receive under that program.
